- The Realtor IS NOT REQUIRED TO WRITE THE CONTRACT TO RECEIVE A COMMISSION.
- The Realtor must be a licensed agent or broker to qualify for a commission.
- Commissions are based on the contract price, & paid upon successful closing.
- The Realtor's commission is based on the Procuring Cause<sup>1</sup> of the sale as defined below...

**3% COMMISION:** 3% Commission is earned when the Realtor is the **Procuring Cause** of the Sale as defined below...

If... The Realtor submits an Acceptable Contract<sup>2</sup> on any home,

Or... If Realtor's Client<sup>3</sup> is presented **BEFORE** a valid Conaway's Client<sup>5</sup> with proper registration<sup>4</sup>.

Or... If <u>Conaway / Realtor's Client</u><sup>3</sup> contracts <u>within 90 days</u> from the <u>Conaway / Realtor's Registration</u><sup>4</sup>
Or... If <u>Conaway / Realtor's Client</u><sup>3</sup> contracts another home <u>within 90 days of a previous Conaway closing.</u>

1% COMMISION: 1% Commission is earned when the Realtor is associated with the Sale as defined below...

If... A Realtor claims a client AFTER a valid Conaway's Client relationship has been established,

### **Definitions\*\*\***:

- 1. <u>Procuring Cause:</u> Realtor's action results in a contract generated by themselves or by Conaway's within acceptable time.
- 2. Acceptable Contract: A contract that has been accepted by both Conaway's & the Buyer.
- 3. Conaway / Realtor Client: A client who has been properly registered using the Conaway's Client Registration<sup>4</sup>
